

Participant Liability Waiver

Note: Before signing, carefully read the statement below. Do not sign unless you fully understand the risk of the exercise.

Initial I, the undersigned, choose to voluntarily participate in the Mt Washington Jessica Neighborhood CERT Earthquake Drill. I understand that participation in the exercise is completely voluntary and activities may involve a certain degree of risk and danger. These risks may include, but are not limited to:

- Falls - loss of balance or falls from apparatus or training structure.
- Strains/sprains - ligament fibers or muscles stretched or torn from overuse, exertion, or twisting of the body.
- Inclement Weather - adverse weather conditions which may subject participant to cold windy and wet conditions.
- Animal/Pest Encounters - dogs, cats, birds, snakes, spiders, etc.
- Travel - to and from training areas
- Physical/Mental exertion/exhaustion - which may result in injury or misjudgment and inappropriate decision making.
- Equipment Failure - Equipment brought in from other agencies may fail.
- Broken bones, allergic reactions, and other serious injuries.

Initial In consideration of being able to participate in this exercise/training, I fully and voluntarily accept these risks. I, for myself, my family, my heirs, executors, administrators and assigns, release, indemnify, hold harmless and promise not to sue, Mt Washington Jessica Neighborhood, Inc., Los Angeles Fire Department, Council District 1, The City of Los Angeles, The City or County Parks, The Holy Virgin Mary Coptic Orthodox Church, or any individual or entity participating in this event or any employee of these entities, or any exercise or training site property owner(s) or private property owners for any injury or damages to myself or my property that may occur as a result of my participation in this exercise/training.

Initial I am responsible for my own medical insurance coverage and emergency expenses and therefore take full responsibility for costs incurred due to any injury.

Initial I am aware that I am participating in activities with a diverse group of individuals. I am responsible for my behavior and will conduct myself in a manner that is courteous and considerate of other participants.

Initial I am aware that I am solely responsible for any equipment that I bring to the exercise and will not hold anyone accountable for damage to this equipment during the exercise.

Initial I am aware that I am responsible for my own transportation to, during and from the training sites. I am responsible for acts committed in any vehicle that I operate, for insurance and for the safety and security of others in the vehicle, myself and my own equipment/vehicle. I also agree if I am a passenger in another vehicle that the entities or persons mentioned in this waiver are not responsible for my safety or liable for any injury incurred while in any vehicle.

Initial I understand that at this event or related activities, I may be photographed. I agree to allow my photo, video, or film likeness be used for any legitimate purpose by the event holders, producers, organizers and assigns.

Initial I represent that I am physically and emotionally able to participate in this exercise and training and that no one connected with the entities or persons mentioned in this waiver will undertake the responsibility to determine my ability to participate.

I am at least 18 years old and have read the assumption of Participant Liability Waiver and understand all of its terms. If I am under 18 years of age, I acknowledge that a parental-guardian signature is required as part of this Release.
